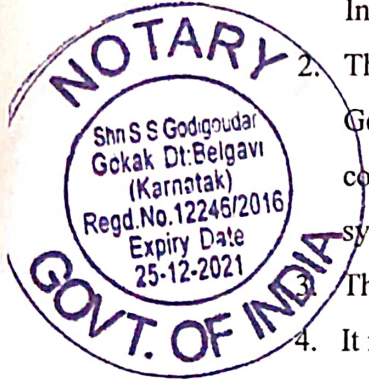

**CONDITIONS**

Appropriate steps to be taken to have own building prior to next year Renewal of Recognition as per pro-forma , Aid rule section 3 rule(9) A

1. This Registration comes under Rule 3(5)(4) of Karnataka Private Education Institutions(Classification and registration).
2. This registration as per Karnataka Children free and compulsory Education act 2012, Govt. Order No. ED 91 Information 2012 Dated 15/11/2012, said order is under the condition of adapting and following time to time changes brought in regarding education system and rules.
3. The Governing Council must follow all the conditions.
4. It is bound to the condition to provide school site, measurement, building, lessons, furniture, financial facilities to the staff etc.
5. The above said Education institution should not open extra section in any situation without the prior permission of Govt.
6. The school should start in the permitted medium and in the same place, same survey number. It should not be changed for any reason.
7. The school should be run only by the permitted Management in the same name and in the same place.
8. The Management should follow all the Govt orders and rules come under Education institutions and the orders passed time to time. It should also follow the rules and regulations of Karnataka Education Act 1983 (Karnataka Act no. 1:95). The rules comes under and formed must be followed by Manageent.




9. According to Govt adisuchane no.ED:175 PMC 95 Dated: 7-9-98 & 9-12-98 this registered High school is permanently unaided.
10. Management should certify in presence a notary in a 20.00 paper stating that the School management will not expect any aid from the Govt.
11. Govt. and Dept. prescribed Text books, exam pattern should be followed.
12. Said School under Language policy, in case if it brought to the notice of Kannada development authority that, school violated language policy, said institution permission will be cancelled under the law.
13. It is under the binding and condition that, any modification regarding volition of language policy or school facilitated under self declared schools by Govt. or court order.
